

The Holiday season is fast upon the community of Crescent Spring Condominiums. Here are some seasonal reminders for residents (old and new!).

• Holiday and Wintertime Reminders

- As winter time approaches, please remember to dispense of dead potted plants.
- The next large trash pickup is **Monday**, **December 15**. It is early this year; however, if you have any large items that need to be dumped, remember to place them in the dog walk area before Monday.
- Pumpkins and other seasonal fruit/vegetable items need to be removed when freezing temperatures persistently set in.
- Please remember that if you attach a hose that has been disconnected, please disconnect it after you are done.
- If 2 inches or more snowfall occur, consideration is given for snow removal of the parking lot. One factor considered is if the weather warms up quickly after the snowfall. It is the resident's responsibility to make sure that the snow is removed from his or her steps and walkway. Bickel St. is the responsibility of the city, so it may be a while before it gets treated for snow and ice. Because that road does not get much sunlight, it will become iced over after a very cold evening. Be cautious when driving down Bickel, so as to avoid hitting the guardrails. The hill going up to Ewing (also known as the "ski slope") is also horrible during bad weather.
- Now that the majority of the fall leaves are off the trees, we will begin the process of cleaning the gutters very soon.
- With the onset of the cold weather, it is important to make sure that your fireplace is cleaned before you begin to use it. Bids are currently being collected to find a company who can clean fireplaces for a nominal fee.
- Also for safety reasons, it is important that all dryer vents are free of lint buildup. It also helps to minimize the amount of time you use to dry your clothes. We are also collecting bids for a reasonably priced company who can clean the inside and outside lines of your dryer vents. We will be notifying you of the name of the companies you can contact to have your fireplace cleaned and dryer vent cleaned. We will also have that information available on the CSC website (www.crescentspring.com).
- If you have a "real" Christmas tree, don't dump it over the ravine or leave it in front of the dumpsters when you remove it from your unit. Call the Metro Government at 574-5000 to see if there are any re-cycle Christmas tree drop offs.
- Break down gift boxes and large cardboard boxes before putting them into dumpsters. Don't pile items outside the dumpsters or next to the trash corrals.
- Keep in mind that stacked firewood cannot touch the floor of your balcony. It cannot also touch the wall of your unit. Please make sure that you put your firewood in a firewood holder so it is not touching the floor.
- Please remember to remove all holiday decorations by the end of January.
