Financials: Several checks signed and financials reviewed.

- Dog Walk Station as Chemical Free: Motion made, seconded and passed to designate the most used station at the intersection of Ledgeview Court and Ledgeview Park Drive as chemical free. The lawn care company will be notified to not treat this area with chemicals.
- Siding and Painting Updates: Todd reported that painting is nearing completion. Siding issues continue on right side of building 15, with woodpeckers. Looking at options to deter this activity. Siding work order on bldg 7 not yet completed. Contractor has been contacted to reattach unit numbers on building 6.
- Regime Rule 15: This rule is being revisited to investigate whether changes are needed. This rule is about owning and caring for pets.
- Dogs Off Leash/ Loose Cats/ Dog Waste: We have mostly responsible pet owners at Crescent Spring. However, complaints have been received regarding dogs not on a leash, dog waste not picked up behind units, and unwanted cat visits at units. Metro rules stipulate dogs must be leashed, and waste must be picked up. Pets at CSC are not to become a nuisance to other owners.

Violation letters are sent and fines issued when non compliance is noted.
